



2011-2012 POWER LEAGUE TEAM AGREEMENT

Players / Parents / Coaches / PDX-VB Club

Objective

1. To provide an affordable volleyball club to assist in the further development of young volleyball players.
2. To develop all volleyball players into well rounded players, and give them the opportunity to play all positions.
3. To have the players, parents, coaches & club director who sign this agreement to be committed to the team and club for the entire season.
4. To assist in the development of recreational youth volleyball programs in Portland Oregon.
5. To provide a positive experience for all players, parents & coaches.
6. To have teams consist of approximately 9 - 12 players, to maximize the playing time and experience of all the players.
7. To have two high energy practices a week, play in two tournaments a month, and play in the regional finals.

Team Rules

1. All Player, Parents, Coaches and PDX-VB Representatives will remain positive and supportive with each other.
2. Any concerns by player, parents, coaches and PDX-VB representatives will need to be addressed and discussed at the earliest opportunity.
3. Parents need to save comments to coaches until the end of practice and/or the end of matches.
4. Player agrees to pay all Club & Coaching fees on specified dates.
5. Player agrees to be at practice on time each week and ready to practice at specified practice times.
6. Player agrees to be at matches on time and ready to play
7. Player agrees to notify the coach in advance of absence or tardiness (24 hours for practice and 48 hours for tournaments or matches).
8. Tardiness and/or absences during the season may cause a player to be suspended prior to a match or for the entire season (it is important that we have your commitment for the season and that the rest of the players on the team know that they can count on their team mates).
9. No jewelry of any kind should be worn during practice or game.

Player Conduct

1. Players will behave themselves at all times according to the rules of the game. It is not acceptable for any player, team, coach or spectator who displays any form of un-sportsman like conduct such as: vulgar language, disrespect or deceit, and may be penalized

Team Uniform

1. PDX-VB agrees to provide:
 - a. 1 - Jersey
 - b. 1 – Sweatshirt or warm-up shirt

Coaches

1. Agree to be at all practices and matches or have another PDX-VB coach, assistant coach or representative at the match or practice. A certificated and CEVA approved coach, with the PDX-VB directors approval, may also fill in.

Monies

1. Once your fees have been paid to the club or coach you will not be entitled to a refund. It will be at the sole discretion of the PDX-VB club, director, and coach as to whether a player is due monies.
2. Club fee of \$385.00 is due December, 1st 2011 (payment plans must be approved prior to 12/1)
3. Coaches fee of \$210.00 due December 15th 2011 (pay your coach directly)
